<u>May</u>

After many more hours getting quotes and checking maps, we narrowed it down to these two options. I rang Girlguiding HQ and left a message and also sent an email. They got back to me about 5 hours later with a quote for staying with them, incredible we were so lucky they had a spot! They were the same price but we would be sleeping on their floor mats and need to bring a sleeping bag, a bit of a downgrade from our dorm rooms, kitchen and hot drinks on tap! YHA could also fit us in, they had space at two branches and the Earl's court location

was better suited for what we were looking for – sadly it would mean needing to charge the members a little extra to make up the extra.

In order to make sure we had a member-led and parent informed decision, I put the dilemma out to the parents. Told them the issue, followed up by the solution:

- A. No extra charge, bring a sleeping bag and stay in Girlguiding HQ?
- B. £45 extra charge but we will have beds in dorm rooms?

Unanimously the members and their parents voted for option B. I got onto the YHA, confirmed the quote into a booking and breathed a tentative sigh of relief.

June

With the accommodation drama resolved, I focused on my last big fundraising push. I needed approximately £200 to cover what I had budgeted to need. I had been prepping for this stall since February, diligently making bracelets with Guide and Ranger across them, laiting 8 stranded friendship bracelets in Guides and Rangers colours and thinking of other ingenious ways to try and raise some funds. The fundraising stall (at county camp Guystonbury) came on the stipulation that all good cost less than £2 so I had to make sure that whatever I was doing was cost effective and have good margins for profit.

Adopt a mini turtle




had the best stall helpers at Guystonbury! By this point all the chocolate tombola had sold out!
